- Approval to Amend Bylaws sections: Section 1 and deleting section 2 and changes to sections A, B, and C.
- Marco Ortiz Elaborated that since the City of San Diego decided to not award us the Business Improvement District (BID) contract, many sections in the Bylaws that give reference to BID members and Associate Members, will no longer apply without the BID contract and therefore changes need to be made throughout the Bylaws to eliminate any reference to "Associate Members" since we will only have one type of "Member" many changes were primarily made to Section 1 and 2 and retaining sections A, B, and C.

- 1- Approval to form the Membership Committee
  - A Motion was presented to establish a membership committee tasked with creating new membership packages. This committee will be chaired by a board member, DeBrenna Glastervann who was self-nominated.
  - Marco Ortiz recommended that once the Membership packages are created by the membership committee; an emergency meeting should be called to promptly adopt and finalize the new membership packages.

  - Marco Ortiz Elaborated that as of July 1<sup>st</sup>, the Diamond Business Association, INC has no members since the City of San Diego through the BID contract established existing ongoing members that would be eligible to vote; therefore, we have to stablish a membership that would then be entitle and eligible to vote.

3- Approval to obtain an estimate and hire a bookkeeper/accountant.

Marco Ortiz has emphasized the need of procuring the services of a new

bookkeeper/accountant because the current fee of \$650 a month is beyond our

capability with our current finances and without the BID contract, the accounting

process will be much simpler, since we will not be creating monthly finance reports

to request reimbursement from the City of San Diego BID program.

In the meantime, his office is currently maintaining day to day book keeping

through Quick Books, on a pro bono basis.

Marco Ortiz emphasized the importance of hiring the new book keeper ASAP to

address any potential conflict of interest. Therefore, it is recommended to search

for the new accounting firm to take over the books ASAP.
