Daniel Hernandez, San Ysidro Health Center



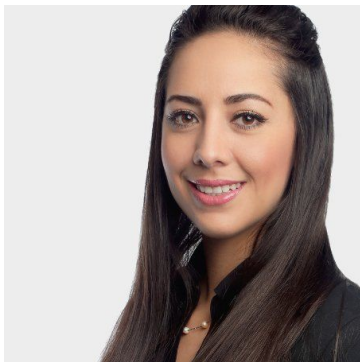
